Gifts to Staff and Volunteers

Each year, especially during the Holiday season, some residents and family wish to recognize the excellent care received from our staff and volunteers with a gift. We have revised our policy on acceptance of gifts to take this into consideration, even though we still encourage gifts given to be items that can be shared by all staff. Should a resident, tenant, family member or visitor wish to give a gift to an individual staff member, only non-cash gifts of \$10 or less are acceptable. The revised policy indicates that staff accepting an individual gift is to report this to their manager immediately.

If you are thinking of giving a gift, please consider giving something that all staff on the unit can enjoy such as a gift basket, box of chocolates or a donation to the Foundation for the benefit of all.

A copy of the revised policy will be available the week of December 16-20 and will be posted on the family bulletin boards on each unit.

Emergency Codes for Visitors

While visiting Perley Rideau, you may have heard a code being called over the intercom and wondered what is going on. We regularly conduct drills for our emergency codes so we are prepared in the event of a real emergency. We have had some feedback from visitors about these codes. Why don't we let people know ahead of time that we are having a drill? We don't announce drills because we want the staff to react as they would in a real emergency. We also know that visitors are not aware of what the different codes mean. All of the codes colours are posted in various locations throughout the facility above the emergency telephones which are located in the halls of the facility.

The important thing to remember is that in all code situations we ask that you follow the direction of the staff. When a code is called, please find a staff member and ask them what to do. The only exception to that rule is when code white 911, which is the code for a threatening visitor, is called. In this case, please make sure that you and the resident you are visiting are safely behind a closed door. Code white 911 is our version of a lockdown in a school.

Code brown= in-facility hazardous
spill
Code orange= community disaster

Pension Information For Part-time Employees

As an eligible part-time employee, you have the opportunity to participate in the HOOPP pension plan. Part-time employees are eligible to join HOOPP after either working 700 hours of earning at least 35% of the year's maximum pensionable earnings (YMPE) which equals to \$17,885 in 2013. The YMPE for 2013 is \$51,100. Eligibility is based on the number of hours worked or wages earned in the year prior to joining HOOPP.
