2	Management Update	
	Mary Boutette, Chief Operating Officer. Mary encourages all family members to engage with the team providing care to your loved one. Each building is supported by a Residence Care Manager – Kerry Tubman (Gatineau), Sam Diceman (Rideau), and Stephanie Kim (Ottawa). Each building also has a PSW Supervisor.	
	Perley Health is outbreak free at this time.	
	Mary shared an invitation on behalf of Melissa Norman, Quality Improvement and Interprofessional Care. Invitation to participate on a focus group exercise to review the Seniors Quality LEAP Initiative (SQLI) survey questions and the importance of each item relative to- quality of life. 	Intergenerational Play Group – on Mondays and Fridays in the Games Room. Coordinated as part of the partnership with Andrew Fleck Childcare Services. The playgroup is open to parents/and their babies/toddlers. Tenants of the Senior Living Apartments and Residents of LTC are welcome to attend. Perley Health is also working with Andrew Fleck to open a Day Care in the main building in the empty space across from the Pharmacy. The offering would give priority to Perley Health Staff and also be open to those in the local community.	

Question from the group added to the discussion that part of the planning is to ensure the health and safety of all participants – infection prevention and control is an important part of the planning.

Expansion ideas – Pre-pandemic Perley Health had considered plans for an expansion. These discussions are being brought forward again, Perley Health is committed to providing a continuum of care and also to serve more adults from the community. Further discussions will take place about the possible ideas for expansion.

Questions:

- There were a number of questions about parking and safety for commuters. Parking areas are well marked and there is a map available online or at the commissionaire's desk. Peak parking usage is around the 3pm shift change.
- Other options for transportation –suggestion to have a discussion with OCTranspo to increase the frequency and variety of service near the Perley Health Entrance.
- Safety at Perley Health Russel Road intersection. Suggestion to ask the city for a traffic light.

Answers:

- Mary noted that all the ideas are worth considering. A parking garage had been investigated as part of a previous expansion plan but the cost was prohibitive.
- Mary noted that visitors can park in any spot on the Perley property, including in the staff parking areas. Visitors however are excluded from access to the Tenant parking area.
- Previous discussions with the city had been successful to provide improved bus stops near the entrance and the illuminated cross walk. It is possible to renew those discussions.

Jay Innes, Communications Director had 3 invitations for the Families and Friends.

4	Grace Welch – Champlain Region Family Council Network, Chair
	Grace has been a long time member of family. councils and of the Champlain Region Family Council Network (CRFCN). The CRFCN area in the Eastern section of Ontario supports 59 homes. Their focus is primarily information sharing and advocacy. They have participated in numerous investigations and studies, such as the 2020 Ministry Staffing Study.
	Each year the CRFCN prepares a priority paper for the various pre- budget discussions and Ministry meetings. The 2023-24 version is attached.

Key priorities center around improving care – implementing person centered care. The CRFCN was a key proponent of the 4 hours of care directive which has been legislated province wide to provide an average of four hours of care. Care is intended to be measured as active front line care. The overall plan involves increased funding to long term care homes to increase staffing to meet the directive. The goal is to accomplish this by 2025.

Improving physical environments – there are a number of models being implemented but the general theme is to evolve to a more "home" like setting.

Improvements in accountability and care.

Inspection reports – how to make them easier to interpret.

Questions – in response to a comment about Agency workers being used instead of employees. Answer – recommendation to provide care with employees rather than agency staff. This generally provides better care as the employees get to know the residents and their needs. It also reduces the overhead costs of agencies that can be extreme. Note that this comment is referencing the employee roles that are indicated within the 4 hours of care, and are not intended to comment on other help and supports families may privately arrange for companionship or care.

Question/Suggestion – Need to provide some focus or spotlight on younger residents, who may not see themselves reflected in the opportunities for senior adults. Answer – Grace mentioned that this had previously been an item of focus for the CRFCN, and it would be possible to add it back into the priorities. She noted that 7% of the LTC population are under 65 years old.

Question – how to raise awareness of needs. Answer – recommendation for onsite visits. Reach out to local MPPs. The MPP for the Perley Health area is John Fraser. Letters to the Minister of LTC. Hon. Stan Cho, Minister, Itcminister@ontario.ca
