

## One Staff Member Tests Positive for COVID-19 at The Perley and Rideau Veterans' Health Centre September 24, 2020 – Ottawa, Ontario

## COVID-19 Update

- The Perley and Rideau Veterans' Health Centre today received confirmation that a frontline staff member working in the Gatineau building on the Gatineau 1 North unit has tested positive for COVID-19.
- The positive case was in contact with a COVID 19 positive person in the community and identified during our regular two-week testing of staff, as mandated by the Ontario Government.
- · The staff member is asymptomatic and self-isolating at home. We wish the individual a rapid and full recovery.
- There are no positive cases of COVID-19 among Perley Rideau residents.
- The outbreak is isolated to the Gatineau building.
- · All indoor and outdoor visits with residents from the Gatineau building are cancelled effective immediately until further notice.
- Only essential visitors and caregivers will be permitted to visit the Gatineau building.
- In consultation with Ottawa Public Health, the Ottawa and Rideau buildings are not on outbreak and indoor and outdoor visits can continue.
- All visitors will continue to be screened and must follow all safety protocols.
- Please help keep our community safe:
  - · Wear a mask;
  - Follow recommended hand hygiene practices;
  - Respect physical distancing limits of 2 m./6 ft.

## **COVID-19 Tests**

Earlier today, a new directive from the Ontario Government addressed testing requirements (link: <a href="https://news.ontario.ca/en/statement/58507/ontario-updates-covid-19-testing-guidelines">https://news.ontario.ca/en/statement/58507/ontario-updates-covid-19-testing-guidelines</a>).

It is the opinion of the Perley Rideau team that this directive does not change the requirement that those entering our high-risk environment attest to a negative COVID-19 test within two weeks of the date of entry.

"Asymptomatic individuals from certain high-risk populations may be considered for testing. This includes workers and residents of high-risk settings such as long-term care homes, visitors of long-term care homes, workers and residents of homeless shelters and other congregate settings."

This testing directive applies to Support Workers, Designated Caregivers and general visitors. Essential visitors – those who have a resident who is very ill and dying –- will be permitted to visit the Gatineau building. Staff will support these essential visitors and make all necessary arrangements to support a safe visit including the wearing of the appropriate Personal Protective Equipment (PPE).
